³⁾ NB: A fee of EUR 35 (DKK 260) is charged for countries where the EU Commission has agreed to, or is negotiating a Visa agreement.

⁴⁾ No fee shall be charged for applications regarding the naturalisation of children below the age of 18 provided the parents - or one of these - were born Danish or have subsequently obtained Danish nationality.

⁵⁾ If several documents are issued together to the citizen or if several products are documented together for VAT refund claim, a fee of only DKK 185 shall be charged.

⁶⁾ If several provisional passports are issued at the same time, the fee for the first passport is DKK 3,850 and DKK 940 for subsequent passports.

⁷⁾ If several provisional passports are issued at the same time, the fee for the first passport is DKK 5,130 and DKK 940 for subsequent passports.
