



Spouses, descendants and dependants of EU/EEA/Swiss Nationals who exercise their right of free movement within the EU/EEA are to submit the following supporting documents. A translation must be attached to any document in Urdu. Please check the boxes below and sign to confirm which documents have been submitted and dispensatory statements about the missing documents. In case, the application is processed with incomplete documents, the Embassy will make the decision with available information only.

Documents to be submitted by all applicants:

- From the 01 July 2019, you should fill in your visa application and pay the application fee online using this [link](#). After you have applied and paid the visa fee online, you must print and sign the cover letter from ApplyVisa and hand in supporting documents and supply biometrics at the Visa Application Centre.**
- One passport photo (the photo should be a passport size colour photo with light background and not older than six months)**
- Current passport (valid at least three months after the intended date of departure from the Schengen member states; the passport must have at least two blank pages for visa sticker and stamps)**
- All previous passports
- Copy of previous visas and stamps of the applicant's passport**
- Copy of EU/EEA/Swiss national's passport (All pages including front and back)

When applicants are descendants of the EU/EEA/Swiss national or of his/her spouse (e.g. children), or ascendants (e.g. parent) of the EU/EEA/Swiss national or his/her partner and more than 21 years of age:

- Documentation that the EU/EEA/Swiss national or his/her spouse/partner supports the family member (e.g. proof of regular payments or money transfers to the applicant's bank account etc.)

When applicant is spouse, cohabiting partner aged 18 or more, or direct descendant under the age of 21:

- Documentation for the family relation, e.g. marriage certificate (Nikah Nama) English translation of marriage certificate, Marriage Registration Certificate, Family Registration Certificate, Wedding pictures, birth certificate etc.**

Parents who support their child who is an EU/EEA/Swiss national:

- Documentation of payments e.g. proof of regular payments, transfer to the child's bank account etc.

Other family member (e.g. siblings, cousins etc.):



Documentation that they are dependants of the EU/EEA/Swiss national or are living under his/her roof in the country they come from (e.g. regular payments to the applicant's bank account etc.)

Other family members who do not fulfil the mentioned requirements:

Documentation that serious health issues make it absolutely imperative that the EU/EEA/Swiss national personally takes care of the person in question (e.g. medical certificate)

Documentation that the EU/EEA/Swiss national is exercising his/her right to free movement in Denmark (e.g. copy of the registration certificate issued by a Danish Regional Administrative body to the EU/EEA/Swiss national, host to a specific address the EU/EEA/Swiss national resides etc.)

If missing supporting documents are not presented promptly (5 calendar days from the application is handed in at Gerry's), the visa application will be decided upon the available documents. Decision on the application will normally take place within 15 calendar days after lodging the application. The period may be extended up to a maximum of 30-60 calendar days in individual cases, if further scrutiny of the application is needed or in cases of representation where the represented state is consulted.

Application processing time counts from the time the application is delivered to the Embassy via Gerry's.

I hereby confirm that I personally have submitted this application for a visa and that all information stated in the application and the supporting documentation is true. I am aware that providing incorrect information or falsified documents deliberately are punishable by both Pakistani and Danish law and will lead to refusal of visa. I am also aware that the processing time is up to 15 days or more, and that I may be required to submit some other documents or to have an interview with Consular authorities. I have also been informed that there is an increased risk of the visa application being rejected if the requested information is not provided within the given deadline.
