<sup>6)</sup> Where several provisional passports or extensions of passports are issued at the same time, a fee of DKK 2,410 shall be charged for the first passport and DKK 1,035 or DKK 1,780 for subsequent passports.

<sup>7)</sup> Where several provisional passports or extensions of passports are issued at the same time, a fee of DKK 3,445 shall be charged for the first passport and DKK 1,035 or DKK 1,780 for subsequent passports.
